Major sections include:

pp. 1326-1335, family of **Sion** and Clarky (McTyer) Alford

Due to the large number of Alford(s) in this massive work, they will not be listed individually in the Booklist. It is suggested that interested readers obtain a copy of the index. We also have a partial copy of the Advance Booklet which the author sent to living descendants of the main couples named in the title for corrections. Included in our copy is the section listing Alford descendants of the Fulmore line.

Charity Self and lived in Amite, LA); **Murray L.**, 607 (b. 1871 and d. 1944, son of Marshall and Charity); **Parker**, 791 (m. Sophia Smith, lived in Buffalo, MO—no date but probably mid-twentieth century); **Pearl**, 607 (b. 1885, daughter of Marshall and Charity); **Susan**, 507 (daughter of John and Rebecca, b. circa 1876); **William**, 291 (m. Susan (Wright) Rambo 1845— no place named, but probably TN).
